LIABILITY RELEASE AND INDEMNITY AGREEMENT

1. I acknowledge that skiing, ski racing, and related activities are HAZARDOUS activities that can result in damage, injury, and/or death. I have made a voluntary choice to participate in these activities despite the risks that are present. In consideration from being permitted to participate, I agree to ASSUME ANY AND ALL RISK OF DAMAGE, INJURY, AND/OR DEATH, which might be associated with or result from my participation in these activities.

2. I agree to RELEASE FROM LIABILITY, to INDEMNIFY AND HOLD HARMLESS, and FOREVER DISCHARGE FROM ANY AND ALL RESPONSIBILITY, the organizers and sponsors of these activities and the following parties:

The above member company ski team / club, its officers and members;

The Connecticut Industrial Ski Council, Inc. (CISC), its Board of Directors, officers, member companies, and sponsors;

The member company / corporation, its owners, agents, affiliated companies, and employees;

Ski Sundown, its owners, agents, affiliated companies, and employees;

Mount Southington, its owners, agents, affiliated companies, and employees;

Sugarbush Resort, its owners, agents, affiliated companies, and employees;

and all other Ski Areas or facilities where CISC events are held, their owners, agents, affiliated companies, and employees;

from any liability claims and demands for any damage, loss, expense, delay, injury, sickness, accident, and death to myself or any person or property, whether caused by NEGLIGENCE, skiing conditions, weather, or for any other reason. This agreement applies to all activities that are IN ANY WAY CONNECTED with my preparation, practice for, and participation in CISC ski races and related activities, and the member company ski team / club ski races and related activities. I also agree that my name as printed above, along with my age / gender category, company team and images may be posted on the website www.ciscskiing.org periodically for the purposes of posting racing results, CISC election results, for CISC awareness advertising or other reasons as approved by the CISC voting board.

3. I, the undersigned, have carefully read and understand this agreement and all of the terms. I understand that this agreement is in effect for one year from the date of my signature. I understand this is a RELEASE OF LIABILITY that will legally PREVENT me or any other person from filing suit or making any other legal claim in the event of any damage to property, injury to myself or other person, my death, or the death of any person. I nevertheless enter into this agreement freely and voluntarily and agree it is binding upon my relatives, heirs, administrators' executors, legal representatives, and me.
